Speakers

Iain Greenway (Director, HED). Iain has been Director of Historic Environment Division (HED) since August 2015. Iain is a Fellow of the Chartered Institution of Civil Engineering Surveyors (FIInstCES) and a member of the Chartered Institute of Marketing (MCIM). He is an Honorary Member and former Vice President of the International Federation of Surveyors (FIG).

Ciarán Fox (RSUA). Ciarán was appointed Director of the Royal Society of Ulster Architects in June 2015 after 10 years with the Construction Employers Federation (CEF). RSUA is a charity dedicated to improving the built environment through good architecture. It is also the professional body for architects based in Northern Ireland and is in alliance with RIBA.

Nicola McVeigh (UAH). Nikki has been Chief Executive of Ulster Architectural Heritage since 2014. Ulster Architectural Heritage have been commissioned by the Department for Communities to develop a baseline report on Climate Change and the built environment.

Dawson Stelfox (Consarc Design Group). Architect and conservation consultant, Dawson has been involved in over 10 years research with Queens University, University of Oxford and Historic Environment Scotland on moisture movement in traditional buildings, specifically in relation to climate change to understand how historic buildings are going to have to be made resilient in order to conserve their historic fabric and ensure they can continue in use.

John Edwards (Edwards Hart Consultants). John is a Chartered Environmentalist and a practitioner in the sustainability and energy efficiency of buildings since 1981 involving buildings of all kinds with its roots in building pathology. Has contributed to numerous standards and guidance including authorship of IHBC guidance on retrofit. Professor on Practice at the University of Wales Trinity St David.

Dermot MacRandal (Senior Architect, HED) Dermot has over 20 year experience of being an architect in the private sector with an increasing interest in Conservation. Since joining Historic Environment Division in 2015 he has worked with archaeologist colleagues on State Care Monuments and is currently involved in putting a new oak roof on Carrickfergus Great Keep.

Manus Deery (Assistant Director, HED) Manus is head of the Heritage Advice and Regulation Branch in HED, managing the Historic Environment Fund, Heritage at Risk, and enforcement as well as strategic initiatives within government, with district councils and with stakeholders. An architect since 1994 he joined the Division since 2000 and currently heads its office at Ebrington Barracks in Derry~Londonderry.
